## 1 Executive summary

The study focuses on the estimation of free-riding share in the field of plastic packaging producers in the Slovak Republic. Free-riding is a phenomenon that occurs when one subject (or individual) benefits from the actions and efforts of another without paying for or sharing the costs. In general, free-riding is considered a failure of the conventional free market system where an organization or a person benefits from public good but does not contribute to the cost of collective provision.

In the field of plastic packaging, free-rider means a producer or distributor placing on the market plastic packaging or packaged products who do not report to a producer responsibility organisation or a public authority, nor otherwise taking financial responsibility or financial and organisational responsibility for the management of the plastic packaging waste; or reports a smaller amount than actually placed on the market<sup>1</sup>. The consequences are that free-riders avoid producer obligations and costs and thus gain a competitive advantage.

The extended producer responsibility scheme<sup>2</sup> is an important environmental policy instrument where producers of specified products bear financial and organisational responsibility for the management of the waste arising from such products placed on the market. Many countries face a challenge in identifying producers falling under the EPR scheme<sup>3</sup>. Most producers are small unregistered manufacturers.

The first framework for an EPR scheme in the field of packaging and packaging waste in the Slovak Republic was introduced by Act No. 529/2002 Coll. on packaging and amendments to certain acts. The data on the amounts of packaging placed on the market, as well as on the amounts of packaging waste generated, recycled or recovered have been monitored since 2003.

Based on experience gained from ad-hoc or planned environmental inspections executed in the Slovak Republic, it has been detected that not all packaging producers have been covered by the EPR scheme.

Estimation of free-riding share in the field of plastic packaging producers in the Slovak Republic was based on the identification of potential packaging producers by analyses and comparison of the Business Register, the Register of Packaging Producers and the FinStat PREMIUM database. Year 2022 was chosen to be the reference year. The amount of packaging waste generated in the Slovak Republic is deemed to be equal to the amount of the packaging placed on the market in the given year. The estimation of the share of free- riders was based on two approaches used - an approach based on data on packaging placed on the market and an approach based on data on plastic packaging placed on the market more detailed described in Sub-chapter 3.5.

Results of the study were provided in an aggregated form at the level of NACE code subclasses due to the protection of confidential statistical data from misuse in all provided and published outputs without the possibility of direct or indirect identification of the entity.

According to the preliminary results of processing the data on packaging placed on the market of the Slovak Republic in 2022 and both approaches, the share of free-riders in the field of plastic packaging in the Slovak Republic was estimated in average at the **level of 13** %.

## 2 Legislative framework

#### 2.1 EU legislative framework

Quality of the data provided on plastic packaging waste is crucial for ensuring the fulfilment of the requirements of the European Statistical System in two areas. These two areas are regulated by Directive 94/62/EC<sup>4</sup> and Regulation (EU, Euratom) 2021/770<sup>5</sup>.

According to Art. 12 of Directive 94/62/EC, Member states are obliged to report to the European Commission data concerning recycling and recovery of packaging waste and data on reusable packaging for each calendar year. The format for reporting this data is laid down by Commission Decision 2005/270/EC<sup>6</sup>.

From 1 January 2021, Council Regulation (EU, Euratom) 2021/770 laying down rules on calculating the own resource based on plastic packaging waste that is not recycled has been applied. According to the Regulation, the EU Member States shall provide the EC with statistical data on the weight of plastic packaging waste generated in the respective EU Member State as well as, on the weight of the recycled plastic packaging waste. The weight of plastic packaging waste that is not recycled shall be calculated as the difference between the weight of the plastic packaging waste generated in a given year, and the weight of the plastic packaging waste recycled in the year that is determined under Directive 94/62/EC. The format for reporting this data is established by Commission implementing Decision Regulation (EU) 2023/595¹.

One of the means to strengthen the re-use of products and further advance the prevention, recycling and other recovery of waste is introduction of the EPR scheme according to Directive 2008/98/EC<sup>7</sup> and Directive 94/62/EC. EPR scheme definition as well as general minimum requirements for EPR schemes are set up in Directive (EU) 2018/851<sup>2</sup>. The EPR scheme represents a set of measures taken by Member States to ensure that producers of products bear financial responsibility or financial and organisational responsibility for management of the waste stage of a product's life cycle.

One of the EPR scheme requirements is to establish a reporting system to gather data on the packaging placed on the market of the Member State and data on the collection and treatment of waste resulting from that packaging.

Generally, there is an assumption, that countries using a "placed-on-the-market approach" to estimate packaging waste generated might underreport their data since not all "market players" meet the EPR scheme requirements. According to Art. 2 point 14. of Commission Implementing Regulation (EU) 2023/595, when estimating plastic packaging waste generated based on placing on the market

data, the data should be complemented, besides other estimations, with the estimated amounts for free-riders; producers below the *de minimis* threshold; self-compliers; after-placed-on-the-market exports; online trade; private imports; private exports; reusable packaging placed on the market for the first time; reusable packaging that became waste any other relevant estimation.

#### 2.2 Slovak legislative framework

Relevant European legislation on packaging and packaging waste was transposed into Slovak legislation by Act No. 79/2015 Coll.<sup>8</sup>, Decree of the MoE SR No. 373/2015 Coll.<sup>9</sup> and Decree of the MoE SR No. 366/2015 Coll.<sup>10</sup>

According to Art. 52(11) of Act No. 79/2015 Coll., a packaging producer is a natural person – entrepreneur or a legal entity who

- a) uses packaging for packaging of goods or fills goods into packaging and places these goods on the market of the Slovak Republic under their trademark,
- b) is a person for whom goods are packaged or filled and under whose trademark these goods are placed on the market of the Slovak Republic,
- c) places on the market of the Slovak Republic packed goods in a manner other than referred to
  in a) or b) or transports or has the goods in packaging transported across the state border of
  the Slovak Republic and places them on the market of the Slovak Republic or for distribution
  in the Slovak Republic,
- d) as a distributor, delivers, for payment or free of charge, packaging to end-users to be used directly for packaging of goods,
- e) as a distributor uses the packaging to package the distributed goods or part thereof, or fills the packaging with the distributed goods, or
- f) places packaging on the market of the Slovak Republic, except persons supplying empty packaging to persons referred to in a), b), c), d) and e) or to a person who packages or fills the goods for a person referred to in b).

The extended producer responsibility scheme in the Slovak Republic is specified in the Part 4 of Act No. 79/2015 Coll. The EPR scheme covers 7 types of products and waste streams stemming from them (electrical and electronic equipment, batteries, packaging, vehicles, tyres, non-packaging products and certain single-use plastic products). General producers' obligations are stated in the First Section of Part 4 of Act No. 79/2005 Coll. Further packaging producers' obligations are specified in the Third Section of Part 4 of the aforementioned Act. The operation of the EPR scheme (registers of producers, authorisation, PRO obligations etc.) are more detailed in the Decree of the MoE SR No. 373/2015 Coll.

According to Art. 27(4) of Act No. 79/2015 Coll., packaging producers and producer responsibility organizations are obliged to report to the Ministry of Environment of the Slovak Republic data on packaging placed on the market as well as data on recycling and recovery of packaging waste. Reporting deadline, reporting frequency, as well as format for reporting the data, are laid down in Art. 15 of Decree of the MoE SR No. 366/2015 Coll.

According to Art. 59 of Act No. 79/2015 Coll., PROs are required to provide the MoE SR with data on the amounts of packaging placed on the market by individual packaging producers covered by the PRO.

## 3 Methodology

#### 3.1 Data sources

a) Business Register (Register of Organizations) according to Art. 20(1)(a) of Act No. 540/2001 Coll. on State Statistics as amended

1,857,706 entities were registered in the Business Register as of June 2023. The number of entities was reduced by 111,393 entities that were not assigned any code according to the national statistical classification of economic activities SK NACE Rev. 2 (hereinafter "NACE code"). The number reduction resulted in the amount of 1,746,313 entities to be considered. For comparison purposes, from this reduced number (1,746,313) of entities in the Business Register were selected entities economically active in 2022 that had assigned the relevant NACE code and at the same time were not registered in the Register of Packaging Producers. The selected set represented 254,739 entities.

b) Register of Packaging Producers according to Act No. 79/2015 Coll.

18,851 entities were registered in the Register of Packaging Producers as of June 2023.

c) FinStat PREMIUM online database (https://www.finstat.sk/)

The FinStat PREMIUM database contained financial data of 365,076 Slovak companies.

d) Database on amounts of packaging placed on the market of the Slovak Republic

The Ministry of Environment of the Slovak Republic provided the project team with a database on the amounts of packaging placed on the market in the Slovak Republic by packaging producers reported to the MoE SR by their producer responsibility organizations according to Art. 59 of Act No. 79/2015 Coll. The database contained data on 9,733 entities.

e) Database on amounts of plastic packaging placed on the market of the Slovak Republic

The MoE SR provided the project team with a database on the amounts of plastic packaging placed on the market of the Slovak Republic by packaging producers and reported to the MoE SR by their producer responsibility organizations according to Art. 59 of Act No. 79/2015 Coll. The database contained data on 432 entities.

#### 3.2 Reference year

Due to the need to have the most up-to-date list of entities available, the year 2022 has been chosen to be the reference year, as the necessary economic data on the entities was available for that year at that time.

#### 3.3 Selection of relevant economic activities

The national statistical classification of economic activities SK NACE Rev. 2 was used for the identification of free-riders in the field of packaging under the extended producer responsibility scheme. The relevant type of economic activity is an activity in which it is assumed that the packaging could be placed on the market of the Slovak Republic. The sections of economic activities are divided into two groups – sections considered to be relevant and sections evaluated as non-relevant for the process of identification of free-riders to the EPR for packaging. The list of relevant and non-relevant sections is provided in Table 1.

From the total number of 526 NACE codes at the subclass level (5 numeric NACE codes) identified in the Business Register, 281 NACE codes were considered to be relevant for the determination of potential packaging producers and were assigned by value (A). The list of relevant NACE codes is provided in ANNEX I.

#### 3.4 Selection of potential packaging producers

The selection of potential packaging producers was based on the analyses and the comparison of the Business Register, the Register of Packaging Producers and the FinStat PREMIUM database. The comparison of the data sources was based on the entity's identification number (Business ID).

The selection of potential packaging producers was carried out at the level of individual NACE codes considering the ratio of the number of entities registered in the Register of Packaging Producers to the number of all entities in the Business Register under the same NACE code.




Figure 1. Number of potential packaging producers by RPP/BR ratio

Because most of the potential producers would fall under the threshold of 3 % (low representation of registered packaging producers to the number of all entities in the same NACE code in the Business Register), the ratio of 3 % was determined as the significant threshold for the further selection of potential producers (the obvious break in the curve in Figure 1), so subsequently only entities within the NACE codes with the ratio of 3 % or higher were taken into further consideration. Thus, the number of 254,739 entities was reduced to 62,776 (potential packaging producers).

The database of entities that were under the aforementioned threshold (less than 3 %) was additionally analysed by comparing it to the FinStat PREMIUM database, containing some economic indicators. Entities that achieved annual revenue of at least 1 million EUR in 2022 were selected as relevant, considering the quantity of potential packaging placed on the market of the Slovak Republic. Using this analysis, another 2,669 entities (formerly eliminated using the

threshold of 3 %) were added to the selected set of 62,776 entities, resulting in the final number of potential packaging producers of approximately 65,500 entities.

The list of potential packaging producers is provided in an aggregated form at the level of NACE code subclasses due to the protection of confidential statistical data from misuse in all provided and published outputs without the possibility of direct or indirect identification of the entity.

The list of potential packaging producers aggregated to NACE code subclasses is provided in ANNEX II.

#### 3.5 Estimation of the share of free-riders

The estimation of the share of free-riders was based on two approaches used:

- approach based on data on packaging placed on the market
- approach based on data on plastic packaging placed on the market.

#### 3.5.1 Approach based on data on packaging placed on the market

The approach was based on the data on packaging placed on the market of the Slovak Republic provided to the MoE SR by the producer responsibility organizations according to Art. 59 of Act No. 79/2015 Coll. Data was available for 9,733 entities (packaging producers) and referred to 2022.

The data from packaging producers was aggregated at the level of NACE code subclasses.

The average amount of packaging placed on the market per one packaging producer (at the level of NACE code subclass) was calculated. This average amount was multiplied by the number of potential packaging producers estimated at the level of relevant NACE codes as referred to in Annex II.

At the same time, the proportional share of the amount of packaging placed on the market to the total amount of packaging placed on the market was calculated at the level of the NACE code subclasses.

The calculated amount of packaging was adjusted by multiplying it by the average value of the proportional share of the average amount of packaging placed on the market for each relevant NACE code subclasses.

It was estimated that free-riders could have placed the amount of approx. 67,200 t of packaging placed on the market of the Slovak Republic in 2022 as referred to in Annex III.

The amount of plastic packaging was estimated by multiplying the amount of packaging placed on the market by the value of 0.23, as the average portion of plastic packaging placed on the market to the total amount of packaging placed on the market annually in the Slovak Republic within the period 2010 - 2021 was 23 % as referred to in Table 2.

Using this approach, it was estimated that free-riders could have placed an amount of approx. 15,400 t of plastic packaging on the market of the Slovak Republic in 2022.

#### 3.5.2 Approach based on data on plastic packaging placed on the market

The approach was based on the data on plastic packaging placed on the market of the Slovak Republic provided to the MoE SR by the producer responsibility organizations according to Art. 59 of Act No. 79/2015 Coll. Data was available for 432 entities (packaging producers) and referred to 2022.

The data from packaging producers was aggregated at the level of NACE code subclasses.

The average amount of plastic packaging placed on the market per one packaging producer (at the level of NACE code) was calculated. This average amount was multiplied by the number of potential packaging producers estimated at the level of relevant NACE codes as referred to in Annex II.

At the same time, the proportional share of the amount of plastic packaging placed on the market to the total amount of plastic packaging placed on the market was calculated at the level of the NACE code subclasses.

The calculated amount of plastic packaging was adjusted by multiplying it by the average value of the proportional share of the average amount of plastic packaging placed on the market for each relevant NACE code subclass.

Using this approach, it was estimated that free-riders could have placed the amount of approx. 18,000 t of plastic packaging on the market of the Slovak Republic in 2022 as referred to in Annex IV.

According to Art. 15 of Decree of the MoE SR No. 366/2015 Coll. on record keeping and reporting obligations, packaging producers and packaging producer responsibility organizations are obliged to report data on packaging placed on the market as well as data on the treatment of packaging waste to the Ministry of Environment of the Slovak Republic not later than 28 February of the following year.

Based on the preliminary results of processing the data on packaging placed on the market of the Slovak Republic in 2022, it is assumed, that an amount of 126,382 t of plastic packaging was placed on the market of the Slovak Republic in 2022. The share of the amount of plastic packaging placed on the market of the Slovak Republic by free-riders in 2022 was estimated in both approaches as stated below in Table 3.

In average, the share of free-riders in the field of plastic packaging in the Slovak Republic was estimated at the level of 13 % based on the forecast of the amount of plastic packaging placed on the market and both approaches mentioned above.

#### 4 Conclusion and recommendations

The share of free-riding in the field of plastic packaging producers under the extended producer responsibility in the Slovak Republic at the level of approx. 13 % was estimated based on the data and information on the economic activities of entities registered in the Business Register, on the data on amounts of packaging and packaging waste gathered in the Register of Packaging Producers, on the financial data gathered in the FinStat PREMIUM database as well as on the data on amounts of plastic packaging and plastic packaging placed on the market of the Slovak Republic by packaging producers and reported to the Ministry of Environment of the Slovak Republic by their producer responsibility organizations according to Art. 59 of Act No. 79/2015 Coll. on waste and amendments to certain acts as amended. Results of the study were provided in an aggregated form at the level of NACE code subclasses.

Based on the findings during conducting the study, the recommendations can be made as follows:

- An analysis of waste composition should be carried out for comparison with the results of the study.
- A unified format for reporting data according to Art. 59 of Act No. 79/2015 Coll. should be approved to increase the quality of the data reported.
- Capacities of inspection activities should be boosted to increase the focus on activities related to controls of meeting legal obligations by packaging producers.
- Producer responsibility organizations should be supported to include new packaging producers in their organisations to cope with, generally in the field of packaging, free-riding.
- Awareness raising and information activities should be increased to inform the business sector about legal provisions related to extended producer responsibility and help with distinguishing whether the enterprise activities fall under these provisions.
